- Parent Education and Training: \$130-\$500
- Travel Expenses: varies, on average: \$5,000-\$10,000 (includes airfare, lodging, meals, expenses, drivers, translators, etc.)
- Expedited Home Study: \$600
- FBI Fingerprinting/ Approval, if applicable: \$50 per adult
- Medical Exam for Visa: \$75-\$500
- Child's Visa: \$325
- Adoption Visa (Colombia): \$265
- Child's Passport and Photos: \$65-\$150
- Adoption Finalization/ Re-finalization, if applicable: \$1,000-\$1,500
- Insufficient Funds Fee: \$50
